#### **MINUTES**

#### FIRST ORDER OF BUSINESS

Roll Call. Public notice of this meeting has been given and a quorum is present.

#### **B. PLEDGE OF ALLEGIANCE & INVOCATION**

At this time Mayor Rachel Moreno asked everyone to observe in the Pledge of Allegiance and visitor David Beck gave the invocation prayer.

#### C. VISITORS OPEN FORUM

Fonteyn Beck spoke at this time on the vulnerability of Winona and asked the Council to address the need for a true city plan to protect the growth of Winona's future. Become proactive instead of reactive. David Beck spoke at this time about the development at 620 Dallas St (packet handed out) stated needing a legal opinion on development if it is admissible to proceed forward on this project. Thomas Banks spoke at this time to say that he is a new resident in Owentown and on 11/02 his gas services were cut off for non-payment. He is requesting the council to change the policy to at least notify customers of disconnects. Seeking a refund of late fees and reconnect fees. Lathen Pilcher spoke at this time regarding the development at 620 Dallas St. The roads will be private roads within the development. Winona is a poor community and can barely afford a 1200sqft home, much less the ability to build a 2story home. Some lots inside the city really are not big enough to build 1200sqft. There were no other speakers after this closing out the visitor's open forum.

#### **MINUTES**

a) Monthly report: Craig McCollum gave an update on the utility department. Water loss held to the same as last month, installed 4 water meters and replaced 6, installed 4 gas meters in Nolan Farms, we got the bids in for the concrete to replace the retaining wall at City Hall, a 24x24 pad for a pavilion at the park, and a pad for the generator for well #5 (Tower), repaired water leaks, the shop is looking good and has been cleaned up. We did receive the CDBG Grant of \$500,000 to redo about 5 roads within the city.

## 2. Park/City Beautification

Updated by Alderman Dee Roden. Got the Christmas decorations up at the park for Christmas. Wanda, Karen, Phyllis, and Shanna volunteered to help get the decorations set up. Working on adding more decorations and finishing the tree in the park. Brother Earl stopped by to discuss the parade. The wild women of Winona are doing a fundraiser for the park and there is a jar up at City Hall for those who would like to participate in the fundraiser.

## 3. Mayor Updates

a) Update on permits submitted for processing.

The only permits have been for solar, Pecan Grove, and generators.

b) Clean-up around town

Smith County came in and talked to several places that needed to be cleaned up around town and we have seen progress on cleaning up of some of these problematic buildings.

Discussion and possible action to update Ordinance 221 Establishing Square Foot
Minimum for single family homes to input verbiage to include offsite built
homes/structures and to include verbiage to build upward if a lot is too small to fit a
