## 1. Utility Department

a) Monthly report: Glenn Trimble gave the water utility update on the loss and managers' report. We have a target percentage we want to reach of 15% and plan on scheduling meter change-outs to recoup some of the water loss. Mayor Rachel Moreno gave the utility update from Craig McCollum. Installed 2 gas line extensions for two different new customers (approx. 800 ft), installed 4 water meters, completed CSI reports on the school, there were a few breaks on the water lines. The storms brought down some trees and we had some issues with the storm siren. We are working with Lexcom to implement a new system for the siren. RRC audit update – write-ups were mostly public awareness, establishing a partnership with paradigm to send these out to the public. We do have a gas leak that was rated a grade 2 leak and should have been rated a grade 1 so we opened it up to bring it back to a grade 2.

Alderman Gary Fox made the motion to approve spending \$3000 on 4 tables and seconded by Mayor Pro-Tem Dee Roden.
