6. Discussion and possible action on the designation of an official bank for the City of Winona.

Mayor Pro-Tem Dee Roden made the motion to keep 1st National Bank of Hughes Springs, Southside Bank and Vera Bank as the official banks for the City of Winona.

All in favor; none opposed. Motion carried unanimously.

Mayor Pro-Tem Dee Roden made the motion to keep Tyler Morning Telegraph as the official newspaper and seconded by Alderman Gary Fox.

9. Administering the Oath of Office to the new Council members.

The statement of officers and the oath of office was administered to Luis Diaz, Gary Fox, and Terry Cole by City Secretary Deana Powell.

10. Discussion and possible action on appointing someone to head the Park/City Beautification committee.

Suggestion of recommendation was made to seek volunteers in the community for this position.

Mayor Pro-Tem Dee Roden made the motion to table this discussion until June's meeting and was seconded by Alderman Gary Fox.

3 in favor; 2 opposed. Motion carries majority vote.

11. Discussion and possible action to appoint the Mayor Pro-Tem. (1-yr term)

Alderman Terry Cole suggested to rotate the position each year so that every member of council gets the chance to serve in this position. Alderman Terry Cole nominated Gary Fox. Alderman Gary Fox made the motion to appoint Dee Roden to be Mayor Pro-Tem and seconded by Alderman Shanna Clark.
